Meeting called to order: Dominic Fohrenkam called board meeting to order –
Thursday 7:03PM , 4-9-09

Minutes: Kathie Fohrenkam made a motion to table the minutes of March 12-09 ,
Robin seconded, all approved. Mary Hanna handed out the minutes 2-12-09 Robin
Nute motioned to approve; Yvonne Malikowski 2nd –All approved

Treasurer: Dominic Fohrenkam presented the balance as Tina Alcala was not
present: Total amount in the Lake LA Friends account is \$2065.56. The previous
balance as of the last meeting (3-12-09) was \$2449.514-2-09. Robin Nute
motioned to approve; Kathie Fohrenkam; 2nd –All approved. (The Friends account
and the Lake LA Park account are one account.) Kathie made a motion to reimburse
Dominic no more than \$60. for the cost of pizza for the band for the carnival March
13-14, 2009. It was their only payment for services. Robin seconded, all approved.

President's report: Dominic thanked Kathie and John Morawski for their help
during the carnival. He also thanked the county especially Carol Helferich and Leah
Ferrassoli for their help. He thanked Pat McGuire for her help as well. The carnival
went well. The owner of the carnival was pleased. There was a continual flow of
people coming and going. We were negotiating to have the carnival back here in
June. Peg Lee, the supervisor of Jackie Robinson, came to Sorensen Park during the
Carnival Event and talked the carnival group into going to Jackie Robinson in June
instead. We are still in negotiation for a return of the carnival for Lake LA Day.

Old Business: The Community Building was discussed. The Board of Directors of
the Lake Los Angeles Park Association discussed the name for the new building. The
Board discussed the importance of the mission statement of the Association - "To
build for the future, a park that will serve our community, bringing together all
people." Because of this strong mission and the fact that this community supports
parks and recreation with an additional tax, the Board would therefore make a
respectful request that the building be named The Lake Los Angeles Community
Center as it will be a gathering spot for the community.

New Business: Yvonne Malikowski delivered a bill for the State Nonprofit fee to
Dominic.

to the Jet Hawks.

- **The Third Annual Motorcycle Run-** The run will be on Lake LA Day, September 19, 2009. The run ends at Sorensen Park. Registration will be between 8-9 AM at MGS in Lancaster.
- **The Third Annual Healthy Butte Run 3K/5K Run** is April 11, 2009 on the same day of the Easter Egg Hunt. Registration for the run/walk will be between 8-9 AM at the park with the races to follow at 9 AM. The Hunt will begin with the fire truck sirens at 11AM.
- **Healthy Park Day** will be the following weekend of April 18, 2009. Flashback will be playing. They are the band that played at the carnival. They are donating their time to the community.

● **Lake LA Day September 19, 2009**

County report- Leah Ferrassoli reported that Dina is on leave. The County is on a budget crunch and so is cutting the hours of the staff members. The Park Board told Leah that Carol they appreciate the work that Carol Helferich does at the Park. The board feels that Carol is instrumental in the great programs that take place at Sorensen Park.
